#### Introduction

- 0.1 The Fourth Meeting of the Eutrophication segment team for drafting the updated Baltic Sea Action Plan (DG BSAP EUTRO 4-2021) was held online on 30 April 2021.
- O.2 All the Contracting Parties to the Helsinki Convention, except for Denmark, European Union and Poland attended the Meeting, as well as Observers from CCB, and WWF. The List of Participants is contained in **Annex 1**.
- 0.3 The Meeting was moderated by Mr. Dmitry Frank-Kamenetsky, Professional Secretary. Mr. Dmitry Frank-Kamenetsky and Ms. Susanna Kaasinen, Associate Professional Secretary, from the HELCOM Secretariat acted as the secretaries of the Meeting.

#### Agenda Item 1 Adoption of the Agenda

1.1 The Meeting adopted the Agenda of the Meeting as contained in document 1-1.

### Agenda Item 2 Actions in the updated BSAP

- 2.1 The Meeting <u>recalled</u> that DG BSAP EUTRO 4-2021 agreed that the formulation of some of the actions is already satisfactory (coloured green), agreed that the next meeting will focus on the actions that need further work (coloured yellow).
- 2.2 The Meeting <u>took note</u> of the draft actions to be considered for the Eutrophication segment of the updated BSAP (document 2-1). The Meeting also <u>took note</u> that DG BSAP 6-2021 reviewed all the actions for which the formulation is already satisfactory (coloured green) and agreed on all actions except EN03 which was reverted to yellow colour.
- 2.3 The Meeting <u>agreed</u> that the formulation of all actions is satisfactory as included in the Excel attachment to the Outcome (coloured green), noting the following ongoing national consultations:
  - Estonia, actions EN03, EE12
  - Sweden, actions EN08, EE07/EN10a/EN10b, EN12, EN13, EN15/EN17
  - Finland, action EN15/EN17
- 2.4 The Meeting <u>took note</u> that the actions for which the formulation was agreed by the Meeting will be sent to review via correspondence to DG BSAP. The Meeting <u>invited</u> the countries to clarify their position as a part of the review by DG BSAP.
- 2.5 The Meeting <u>took note</u> that the Secretariat had proposed target years for actions that were lacking target years but did not have time to consider them.
