Agenda Item 1 Adoption of the Agenda

Agenda Item 2 Preamble for the sea-based activities segment

DG BSAP 1-2020 agreed that the whole drafting group will work on the overarching preamble while the segments teams will be established to work on the different segments (eutrophication, hazardous substances and litter, sea-based activities, biodiversity). DG BSAP 1-2020 also agreed that the segment teams will start their work by reviewing the drafts of the segment-specific preambles in the autumn 2020, concomitantly with their submission to the GEAR 23-2020 meeting.

The Meeting is invited to <u>take note</u> of and <u>comment</u> the segment preamble for sea-based activities noting the comments given by MARITIME 20-2020.

Agenda Item 3 Rephrasing existing actions

HOD 58-2020 agreed in principle on the rephrased and concretized existing HELCOM actions to be transferred to the updated BSAP with the understanding that further drafting based on the written comments will take place. Contracting Parties were invited to provide concrete proposals for rephrasing of specific actions to the Secretariat to be considered in the further development of the actions. Some comments regarding the actions under the sea-based activities were received after HOD 58-2020.

The Meeting is invited to <u>take note</u> of the comments and <u>continue</u> drafting of the actions based on the comments received with the aim of submitting a final proposal for HOD 59-2020 (document to be submitted by the Secretariat).

Agenda Item 4 Next steps

The Meeting is invited to <u>take note</u> that the segment teams will continue the drafting of the preambles and operative sections based on the guidance from HOD, in spring 2021.
