Netherlands	The national authority (Rijkswaterstaat) aims at working together with NGOs for the preparedness and response to oiled wildlife incidents. Rijkswaterstaat has financially enabled coastal rehab centres to set up an umbrella organisation in 2008. Via a project (2017- 2022) this umbrella organisation will be expanded to include a variety of NGOs who are willing	Semi-formal, not via a covenant, but via a multi-year project with training, exercises, research and development.
