Re. Invitation to the HELCOM BSAP UP workshop on eutrophication for the consideration of proposed new actions (HELCOM BSAP UP WS-EUTRO 2020), 26 – 27 August 2020, Helsinki, Finland

Dear Colleagues,

With reference to the Outcome of the 57th Meeting of the HELCOM Heads of Delegation (HOD 57-2019, paragraph 3.14), I have the pleasure to invite the Contracting Parties to the Helsinki Convention and Observer Organizations to the HELCOM BSAP UP workshop for the evaluation of proposed new actions for eutrophication (HELCOM BSAP UP WS-EUTRO 2020) that will take place at the premises of the HELCOM Secretariat, (Katajanokanlaituri 6b) Helsinki, Finland.

The workshop will be **opened on Wednesday 26 August at 10.00** and is expected to end at **Thursday 27 August at 15.00**.

Note that the workshop is held back to back with the BSAP UP workshop on Hazardous substances and litter, taking place 24 - 25 August 2020, also at the HELCOM Secretariat. Due to the COVID-19 related travel restrictions the organization of the BSAP UP workshops has been moved from the originally planned May 2020 to autumn 2020. Please see Annex 1 for the overall timetable of the workshops.

The workshop is convened to evaluate proposed new actions for the updated Baltic Sea Action Plan (BSAP). Key background information to the workshop will be the results of the analysis of sufficiency of measures (SOM analysis) that is carried out to support the BSAP update and the synopses on new actions for the updated BSAP that have been submitted to HELCOM. At the workshop commonly agreed criteria will be applied to support the evaluation. Experts on measures to reduce land-based input of nutrients are encouraged to participate as well as national representatives of HELCOM Working Group PRESSURE and AGRI. In addition, countries are invited to consider nominating experts working with the national programmes of measures. Conclusions from the Workshop will be submitted to relevant HELCOM Working Groups for consideration.

Information for the Workshop will be made available in the HELCOM Meeting Portal on the HELCOM BSAP UP WS-EUTRO 2020 [Meeting site](#) (please see the [instructions](#) for *signing up* and *signing in*). Participants are kindly requested to *register to the Workshop* by answering the [Participation Survey](#) not later than **19 August 2020**.
